Summary of 2018 Annual Meeting Minutes

The 2018 Annual Meeting of the Members of Sac Osage Electric Cooperative, Inc. was held Tuesday, June 12, 2018, at the offices of the Cooperative, 4815 East Highway 54, El Dorado Springs.

Tables for member registration were open from 5:00 p.m. to 6:30 p.m. Names of those who registered were entered into a drawing for prizes to be awarded later in the meeting.

Entertainment was provided by "Robin's Hood". Following the Pledge of Allegiance, the National Anthem and the prayer of invocation, Neale Johnson, President of the Board, called the meeting to order. He announced Chris Hoberock, attorney, was appointed by the board to conduct the business portion of the meeting. Mr. Hoberock announced that 233 registered members were required for a quorum. A total of 398 members had registered, so the meeting proceeded.

The Inspectors of Election/Credentials Committee Members were introduced and administered an oath. Candidates for the three positions on the board were introduced: District 7: John (Jim) Murray, District 8: Amy Hedrick and Kenneth Hacker, and District 9: Neale Johnson. Mr. Hoberock stated that according to the Bylaws unopposed candidates are automatically elected without a vote; therefore, John (Jim) Murray and Neale Johnson were declared elected.

Upon motion, second, and voice vote, the Minutes of the 2017 Annual Meeting were approved. Copies of the minutes were available at the meeting to any member.



Members heard reports from the Cooperative's President, Treasurer and General Manager. During the business meeting the floor was opened for any unfinished business and or new business. No member requested recognition for unfinished business or new business.

2019 ANNUAL MEETING PRESIDENT'S REPORT

On behalf of the Sac Osage Electric Board of Directors and staff, it is my privilege to welcome you to the 80th Annual Meeting Members. This year the meeting will be held on Tuesday, June 11th, at the Cooperative headquarters on Highway 54 east of El Dorado Springs. We invite you to join us for an evening of food, entertainment and prizes. Our Annual Meeting will begin at 6:30 PM. We feel that it is important for the membership to be engaged and educated about the business of their Cooperative. We feel very fortunate that membership attendance at our annual meeting continues to be strong and this contributes to the success of Sac Osage Electric.

In 2018 your Cooperative had another good year and continues to be efficient and responsible in its operation. As was mentioned last year, to remain financially responsible, a change in our billing rate structure was necessary. This change will provide more equitable rates for the membership. The new rate design has been explained in various formats including the "Rural Missouri" publication and took effect on April 1st. The rate design was created to better provide fairness for the members in supporting the maintenance and

operation of our electrical system as well as allowing members to use off-peak hours to manage their electrical usage. A more detailed financial statement will be provided in the reports of the Secretary-Treasurer and Manager.

We regret the retirement of long-time director Don Levi, who represented the members of District 3 for the Cooperative. Don was a faithful, dedicated director who gave untold hours of service to the Cooperative. Don was also the Sac Osage Electric representative to the Association of Missouri Electrical Cooperatives (AMEC) and drove many miles attending those monthly meetings in Jefferson City. Don and his wife Chris are moving to Lawrence, Kansas, to be closer to family. We give Don our heartfelt thanks and best wishes for the future. The new director for District 3 will be elected at the Annual Meeting. Tim Minehardt, Director of District 1, was elected to be our representative to AMEC and we look forward to him serving the Cooperative in that position.

The Cooperative has recently completed a three-year effort to replace all of the old analog meters with new state-of-the-art digital meters. Although this has been a labor intensive project, we know that the new meters will provide many benefits in efficiency and enhance our ability to make timely repairs to the system.

Right-of-way clearing is a never-ending endeavor necessary to maintain the integrity of the system. Keeping the process going costs us about \$1 million a year, but the benefits exceed the cost. Weather related outages and other system damages have been significantly reduced with this aggressive management practice.

We always want to express our sincere appreciation to our employees for the outstanding jobs they perform for the Cooperative. The hours they spend, many times in very difficult and dangerous circumstances, are truly appreciated. Each employee is critical to the success of the Cooperative. Our employees represent Sac Osage Electric to the membership and are our greatest

As you may have read, electrical cooperatives across the state and the nation are participating in an initiative to create habitats for Monarch butterflies which have been in a critical decline for several years. Flower gardens containing milkweed plants, the major food source for the Monarchs,

2019 ANNUAL MEETING TREASURER'S REPORT

It has been my privilege to serve you for the last year as Sac Osage Electric Cooperative's Secretary-Treasurer. As a member of the Board, one of my primary duties is to represent you in the Cooperative's annual budgeting-making process.

The annual budget is affected by sales revenue more than any other single factor, with residential sales currently representing 92% of total revenue. Depending on the weather, residential sales can fluctuate significantly from year to year. After three years of mild weather and slow growth, 2018 saw sales increase by 12.9% over the previous year due to both abnormally cold and hot weather conditions. The 2019 budget assumes that normal weather patterns will return in 2019, and that any anticipated sales growth will be offset by energy efficiency measures and behavioral changes caused by the new residential rate redesign.

Purchased power is our largest single expense. Purchased power now represents about 52% of the total cost of electric service. In 2019, KAMO Power announced a rate

decrease, which is being partially offset by a net increase in the kW billing demand charges. Our 2019 budget reflects an overall decrease in power costs of 3.84%, or roughly \$376,275. KAMO Power's rate decrease, along with solid earnings following a rate increase by Sac Osage Electric in 2018, has eliminated the need for any rate increase in 2019.

The 2019 Construction Work Plan calls for total spending of \$2,538,125 for: new extensions, tie lines, and line conversions; replacement of bad poles, transformers, and regulators, and; AMR improvements and miscellaneous distribution upgrades and replacements. This investment in new and improved infrastructure is 22% above the 2018 Construction Work Plan level.

The Board has approved \$1,100,000 for contract tree-trimming in 2019 to clear trees, branches, and foliage away from power lines coming out of the Mt. Zion and Damascus substations. \$75,000 has been budgeted for herbicide treatment of rights-of-way coming out of the Walker and Taberville substations.

This will greatly reduce tree-related outages and decrease the amount of damage caused by storms.

Total margins being allocated to our 2018 members amount to \$1,902,054. These margins will eventually be returned to the membership based upon the amount of revenue each member contributed in 2018. During the year ending December 31, 2018, total refunds authorized to patrons amounted to \$955,000.

Our independent auditor, Kevin Kelso CPA PC PA, recently reported that the 2018 financial statements complied with generally accepted accounting practices. The audit revealed no misstatements of information and all recorded transactions met RUS rules and regulations. I am pleased to report that the Cooperative concluded 2018 in an acceptable financial position.
