2020 Annual Meeting To Be Held September 22nd

At a special meeting in March the Board of Directors, at the recommendation of the Cooperative attorney, re-scheduled the Annual Meeting for Tuesday, September 22, 2020. This is a change from the traditional date in June.

With the uncertainty surrounding the coronavirus outbreak, the Board chose a September date to ensure there would not be a last second cancellation of the Cooperative's biggest annual event. By making the change in March, the Cooperative was able to work with the many parties involved to secure the September date and avoid possible fees for last minute cancellation.

Because the Rural Missouri requires that Sac Osage News be submitted well in advance of publication, the April issue contained the June date for the Annual Meeting. It also included nominating petitions for members in district's 4, 5, and 6. Though the Annual Meeting date given was in-

correct, the petitions were still valid. There is no prohibition against having the nominating petitions sent out and returned several months before the Annual Meeting, so elections, if needed, will take place at the September Annual Meeting based on the petitions in the April issue. Because of publication deadlines, at the time of the writing of this article it is not known how many nominations there will be in each district and if an election will be required.

The September Annual Meeting will be a different experience for Sac Osage members, but they will find the event familiar and as enjoyable as always. There will still be great family entertainment. Delicious food will be served to all members and guests. All members will be eligible to win prizes that will make them want to stay until the meeting is adjourned. Ice cream sandwiches will still taste great even if it is not ninety degrees in the building.

Understanding Your Electric Bill

1. Account number identifies the specific location and the member's billing information. This is the easiest way to reference your account if you call into the cooperative or want to make a payment on-line.
2. This is how SOEC addresses service locations. This stays the same even if the account transfers to a different member. This number can found on meter pole.
3. Date of the present meter reading.
4. The reading from the face value of the meter. The previous value is subtracted from the present value to get the kilowatt hours used. These are the KWH used to figure the energy charges.
5. Account activity since the last bill including penalty charges and other adjustments.
6. This section gives members the chance to change where they want their future bill sent or their phone number. Just return the bottom box with payment and employees will make the changes.
7. This box appears every 3 months and members should check to make sure it contains the primary number they want the cooperative to use to contact them.
8. Gives the kilowatt hour history for this account. Members can see how their energy use changes month to month or compares to last year.
9. Important announcements, including delinquency notices and capital credit allocations, will appear here in green text as needed.
10. This shows the member's district. Each district has a director who represents them on the Cooperative Board.
11. Members who have signed up for Operation Round-Up will see this line showing their donation for this month.
12. This is the fixed minimum charge for equipment to provide electric service.
