Summary of 2016 Annual Meeting Minutes

The 2016 Annual Meeting of the Members of Sac Osage Electric Cooperative, Inc. was held Tuesday, June 14, 2016, at the offices of the Cooperative, 4815 East Highway 54, El Dorado Springs.

Member registration was open from 5:00 p.m. to 6:30 p.m. Names of those who registered were entered into a drawing for prizes to be award-ed later in the meeting.

Entertainment was provided by "Randy Newman aka Doofus". Following the Pledge of Allegiance, the National Anthem and the prayer of invocation, Neale Johnson, President of the Board, called the meeting to order. He announced Chris Hoberock, attorney, was appointed by the board to conduct the business portion of the meeting. Mr. Hoberock announced that 232 registered members were required for a quorum. A total of 343 members had registered, so the meeting proceeded.

The Inspectors of Election/Credentials Committee Members were introduced and administered an oath. Candidates for the three positions on the board were introduced:

2017 ANNUAL MEETING PRESIDENT'S REPORT

The Board of Directors, management and staff invite you to the 78th Annual Meeting of Members of Sac Osage Electric Cooperative. Please join other Cooperative members and employees on Tuesday, June 13, 2017 to enjoy food, entertainment and fellowship as we conduct the business of the Cooperative. The business portion of the meeting will begin at 6:30 p.m.

This January began with the retirement of two of our long-time employees, Nahwana Maslen (Accounting Clerk) and Rodger Culbertson (Line Superintendent). Each had provided over 40 years of dedicated service to the Cooperative and they will be missed. Due to these retirements, a number of staff members have transitioned to new positions and responsibilities. They are to be complimented on how well they have handled the changes. All of our Cooperative employees are to be commended on their skill and dedicated service to the membership.

Your Board of Directors stay educated and well informed with Cooperative issues on the state and local level through the Association

of Missouri Electric Cooperatives, Associated Electric Cooperative Inc. and KAMO Power. These organizations are central to our distribution cooperative's business. Board Director Don Levi is our representative to the Association of Missouri Electric Cooperatives in Jefferson City, Missouri. Board Director Jim Murray is our representative to KAMO Power in Vinita,

Oklahoma. The Cooperative also receives support and guidance from our national organization, the National Rural Electric Cooperative Association. Last year, Sac Osage Electric was also proud to become a member of Touchstone Energy Cooperative, which provides technical and informational support to cooperatives nationwide.

Our right-of-way clearing continues to proceed efficiently. As you travel throughout our service area, please notice the great progress that has been made. While this winter was mild, this clearing program has proven to be effective in reducing power outages throughout the year.

The Cooperative continues to be aggressive with system maintenance and upgrades. The completion of the Geographic Information System (GIS) mapping of our electrical system last year has helped identify and locate areas of concern. The Cooperative has replaced over 170 bad poles in just the first 3 months of this year. Additionally, a 3-year meter replacement program will soon be complete. This program required the replacement of all old analog meters with new state-of-the-art digital meters. This technology upgrade will greatly enhance and improve the accuracy and efficiency of the system.

Throughout the year, the Board of Directors have continued to address the difficult cost and rate structure issues it faces. Recent state legislative action and evolving federal regulatory guidelines create uncertainty in many areas. Sac Osage Electric strives to be responsive to the needs of its 8,600 members and provide the most cost-effective and reliable power possible.

Last year we encouraged the membership to sign up for Operation Roundup, where electric bills are "rounded up" to the next whole dollar, which would amount to no more

than \$11.88 per year. While we have had some additional participation in the program, we would still appreciate greater numbers. All of the funds that are generated are dispensed to local charities. Please call the Cooperative office to participate. When you call the office, you might also request information about the various payment options that are available, such as prepay, level pay, autopay, payby-phone, Smarthub and ACH bank draft. One of these options might simplify your payment experience.

2017 ANNUAL MEETING TREASURER'S REPORT

It has been my pleasure serving you as Sac Osage Electric Cooperative's Secretary-Treasurer for the past year. One of the duties of your Board is to assist management in the budget- making process.

The basis for a reliable 2017 budget depends on an accurate prediction of sales. Residential kWh sales, which represent almost 92% of our revenue, are vulnerable to fluctuations caused by weather. For 2017, budgeted sales were increased by just 0.3%, predicting that any increase in members served would be largely offset by energy efficiency measures. No rate increase was passed along by KAMO Power in 2017, with budgeted purchased power costs going up only 0.2%.

The 2017 Construction Work Plan calls for budgeted total spending of \$3,445,685 for: 118 new member extensions; two single-phase to threephase conversions on the Iconium #8 feeder; continued replacement of

bad poles identified during GIS mapping; and regulator, capacitor and miscellaneous distribution equipment upgrades. We are also in the final year of our 3-year Automatic Meter Reading (AMR) system upgrade, with budgeted costs in 2017 of \$387,761.

To preserve the progress made over the last several years in our right-ofway maintenance program, the board budgeted \$240,000 toward spraying the right-of-way on lines served by the Lockwood, Arcola, Bona and Cedar Springs Substations. Right-of-way clearing for lines served by the El Dorado Springs and Walker substations is budgeted at \$1,008,090, which is roughly the 2016 level.

Our independent auditor, Kevin Kelso, from Mission, Kansas, recently reported to the board that all 2017 financial activities and records complied with generally accepted accounting practices. The audit revealed no misstatements of information and all

recorded transactions met RUS rules and regulations. Therefore, I am pleased to report that the cooperative ended 2016 in an acceptable financial position.

The total margins to be allocated to our 2016 member consumers were \$1,519,421.45, which will help finance future cooperative capital improvements. These margins will eventually be returned based upon the amount of electricity each member purchased in 2016. During the year ending December 31, 2016, total refunds authorized to patrons amounted to \$750.000.
